Confirmation must be received that your bank account has been updated prior to acceptance of a redemption request. To avoid fraudulent requests, we will not make any payments to third party bank accounts. There may also be a delay in finalizing payment to ensure that the redemption request is genuine. No interest is payable for any delay in finalizing payment of your redemption money.

## 4 Signing instructions

By signing this form:

- I/we agree that PIMCO are entitled to act on the instructions, without further enquiry and these instructions supersede and have priority over all previous instructions in respect to my/our investment.
- I/We agree that any payment made according to instructions received by post, courier, email or fax shall be a complete satisfaction of PIMCO's obligations, despite any fact or circumstances such as the payment being made at the request of my/our authorised representative without my/our knowledge or authority; and
