**PIMCO DYNAMIC CREDIT INCOME FUND (“PCI”) ANNOUNCES VOTING RESULTS
OF ANNUAL MEETING OF SHAREHOLDERS**

All Board nominees overwhelmingly elected, with over 83% of voted shares in favor of each Board nominee

New York, NY (May 7, 2015) – PIMCO Dynamic Credit Income Fund (NYSE: PCI) announces that shareholders have overwhelmingly elected current Trustees Craig A. Dawson, Bradford K. Gallagher and James A. Jacobson, as Trustees to the Fund’s Board, defeating the nominees proposed by hedge fund Ironsides Partners by over 41.5 million votes.

Messrs. Dawson, Gallagher and Jacobson were nominated by PCI’s Board of Trustees.

Robert Knapp and Richard Cohen, who were nominated by Ironsides Partners, were not elected.

IVS Associates, Inc., the independent inspector of elections at PCI’s annual shareholder meeting, has certified the results.
