The American Jobs Creation Act of 2004 allowed ETFs having regulated investment company status to designate amounts of QII and STCG as exempt from Nonresident Alien Withholding Tax ("NRA Withholding Tax") when paid to non-U.S. shareholders with appropriate tax documentation. The exemption expired with the PIMCO ETFs 7/7/15 payment date but has since been extended permanently retroactive to 7/7/15 with the "Protecting Americans from Tax Hikes Act of 2015" enacted on 12/18/15.

The amounts set forth below have been identified as exempt from NRA withholding tax and may be subject to revision. We recommend that shareholders consult their tax advisor for further information.
